- 1. Amendment to Article 9, entitled "Amendments", Section 9.1 of the Articles of Incorporation to read as follows:
- 9.1) Amendments. Subject to the provisions of Section 9.2 of this Article 9, amendments to the Articles of Incorporation shall be proposed and adopted in the following manner:
- (a) Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.
- (b) A resolution for the adoption of a proposed amendment may be proposed either by a majority of the Board of Directors or by not less than 20% of the members of the Association. Except as elsewhere provided, such approvals must be by not less than 75% a majority of the entire membership of the Board of Directors and by not less than 75% of the votes of the entire membership; or by not less than 80% of the votes of the entire membership of the Association voting in person or by proxy once a quorum has been established. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing such approval is delivered to the Secretary at or prior to the meeting.
