ARTICLE I

NAME

The name of this Corporation shall be Florida Wildlife Hospital & Sanctuary, Inc.

ARTICLE II

LOCATION

The principal office and hospital location shall be 4560 North U.S. Highway 1, Melbourne, Florida 32935. The Corporation may also have offices at such other places, within or without its State of Incorporation, where it is qualified to do business as its business and activities may require, and as the Board of Directors may from time to time designate.

ARTICLE III

PURPOSE

- A. To provide medical assistance and rehabilitation to injured, sick and orphaned Florida native wildlife and migratory birds, with the goal being to return them to an independent existence.
- B. To provide quality wildlife education through media presentations and events to the general public.

ARTICLE III.1

IRS SECTION 501[C]3 PURPOSES

A. Limitations On Activities: No substantial part of the activities of this Corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation; and, the Corporation shall not intervene or participate (including the publishing or distribution of statements) in any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these bylaws or of the Corporation's Articles of Incorporation, the Corporation shall not carry on any activities not permitted to be carried on:

- 1. by a corporation exempt from Federal Income Tax under S501[C]3 of the Internal Revenue Code of 1953 (or the corresponding provision of any future United States Internal Revenue Law) or
- 2. by a corporation contribution to which are deductible under S170 of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

B. Prohibition Against Private Inurement: No part of the net earnings of this Corporation shall inure to the benefit of or be distributed to its Directors, Officers or private persons, except that this Corporation shall be empowered to pay reasonable compensation for services rendered, and to make payments and distributions in furtherance of the purposes set forth in these Articles.

ARTICLE IV

THE BOARD OF DIRECTORS

- A. Director candidates shall be nominated and elected by a majority vote of the existing Board Members.
- B. Any vacant position on the Board shall be filled by the President. The President shall appoint a replacement with approval of two-thirds of the Board. The replacement's term shall be the same as that of the Board Member who is being replaced.
