ARTICLE X

BOARD OF GOVERNORS

6. In order to qualify to serve on the Board of Governors, each member of the Board must be the record title owner of a Dwelling Unit within Pine Island Ridge during the term of his or her office. A person acting under a power of attorney from a Dwelling Unit Owner is precluded from serving on the Board unless he or she is also a record title Dwelling Unit Owner. If a Governor is absent-from-three (3) regularly scheduled Board of Governors meetings-during-his or her-term of office, the Governor shall-be-considered-to-have-vacated his or her-position as a Governor and shall-be-automatically removed from the Board of Governors. Further, the Governor-removed shall not be eligible-to-re-serve-as a Governor for a period of one (1) year from the date-of-his-or-her removal.
