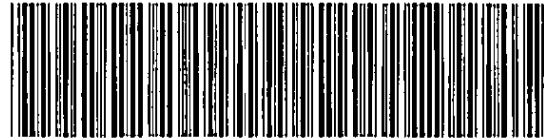

**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
SORRENTO PARK CONDOMINIUM ASSOCIATION, INC.
DOCUMENT NUMBER OF CORPORATION: 725918**

Pursuant to provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

1. The Articles of Incorporation have been amended as follows:

Section 9.1 of the Articles of Incorporation is amended as follows:

9.1 Amendments. An amendment may be proposed by either the Board of Directors of the Association or by the members of the Association. A proposed amendment must be approved by the membership as further described below. Prior to presenting a proposed amendment to the membership for approval, a proposed amendment must be approved by the Board at a duly noticed Board meeting. Once the Board determines that the proposed amendment is to be presented to the membership for approval, the Board shall provide notice of a membership meeting at which the amendment is to be considered by the membership. At the duly noticed membership meeting, the amendment must be approved by a majority of the members that are present (in person or via proxy), provided a quorum is present in person or by proxy. The proposed amendment shall be effective when it is recorded in the Public Records of Sarasota County, Florida.

~~Subject to the provisions of Section 9.2 of this Article 9, amendments to the Articles of Incorporation shall be proposed and adopted in the following manner:~~

~~(a) — Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.~~

~~(b) — A resolution for the adoption of a proposed amendment may be proposed either by the board of directors or by the members of the Association. The proposed amendment must be approved by not less than seventy-five percent (75%) of the entire membership of the board of directors and by not less than seventy-five percent (75%) of the votes of the membership present and voting at any meeting at which a quorum is present; or by not less than eighty percent (80%) of the votes of the entire membership of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing such approval is delivered to the secretary at or prior to the meeting.~~

2. The date of adoption of the amendments was January 6, 2020, and they are effective upon recording in the Public Records of Sarasota County, FL.

3. The amendments were approved and adopted by the members of the Association and the number of votes cast for the amendments were sufficient for approval.

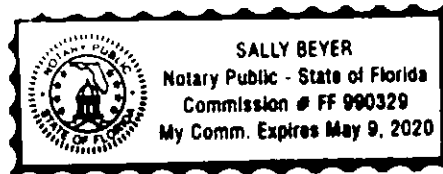
