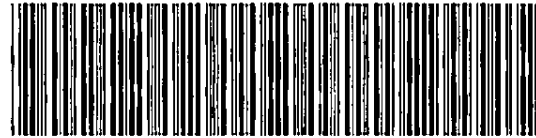



**W I T N E S S E T H :**

WHEREAS, the Articles of Incorporation of the Association were originally filed with the Florida Secretary of State on May 3, 1973 (Document Number 726322).

NOW, THEREFORE, the President and Treasurer of the Association hereby certify that:

The Amendment to the Articles of Incorporation, set forth below, has been properly and duly approved and adopted at a Members Meeting conducted on DECEMBER 11, 2018. The number of votes cast in favor of the Amendment is sufficient for approval. Further, the Amendment to the Articles of Incorporation set forth below has been properly and duly approved by the Board of Directors. The Association has properly approved and adopted the Amendment, set forth below, to the Articles of Incorporation pursuant to the provisions of the Articles of Incorporation.

Article V, Section A of the Articles of Incorporation shall be amended to read as follows:

"A. The affairs of the Association will be managed by the Board consisting of the ~~number of Governors determined by the By-Laws, but not less than three(3) Governors, nor more than seven(7) Governors.~~ number of Governors determined by the By-Laws, but not less than three(3) Governors, nor more than seven(7) Governors. Governors need not be members of the Association."
