ARTICLE X.

Amendments

Amendments to the Articles of Incorporation shall be composed and adopted in the following manner:

- B. A resolution for the adoption of a proposed amendment may be proposed either by the Board of Directors or by the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, provided such approval is delivered to the Secretary at or prior to the meeting. Except as elsewhere provided, such approvals must be by a majority of the votes of the entire membership of the Association. either by
 - 1. Such approvals must be by not less than 75% of the entire membership of the Board of Directors and by not less than 75% of the votes of the entire membership of the Association; or
 - 2. If the proposed change to the Articles of Incorporation has received unanimous approval of the Board of Directors, then it shall require only a majority vote of the membership to be adopted; or
 - 3. By not less than 80% of the votes of the entire membership of the Association.
