**ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION
OF
JEWISH COMMUNITY CENTER OF CENTRAL FLORIDA, INC.**

Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following Articles of Amendment to its Articles of Incorporation:


1. The name of the Corporation is JEWISH COMMUNITY CENTER OF CENTRAL FLORIDA, INC. (the "Corporation").
2. Article I of the Articles of Incorporation of the Corporation is amended to read as follows:

ARTICLE I
