

ARTICLE IX - AMENDMENTS

Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner:

- (1) Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a
- (2) A resolution approving a proposed amendment may be proposed by either the Board of Directors or by the members of the Association. Directors and member not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing such approval is delivered to the secretary prior to the meeting. Except as elsewhere provided;
- (a) such approvals must be by not less than <u>a majority</u> ty five percent (75%) of the entire membership of the Board of Directors and by not less than <u>a majority</u> seventy five percent 75%) of the votes of the entire membership of the Association.; or
- (b) by not less than 80% of the votes of the entire membership of the Association.
