AMENDMENTS TO ARTICLES OF INCORPORATION OF DELRAY DUNES GARDEN VILLAS, INC.

ARTICLE II

PURPOSE

1. The purpose for which the Association is organized is to provide an entity pursuant to Section 711.12 of the Condominium Act of the State of Florida, Chapter 718, et seq., Florida Statutes, as it may be amended from time to time which is Chapter 711, Florida Statutes 1965, for the operation of DELRAY DUNES GARDEN VILLAS, INC., a condominium located upon a portion of the following lands in Palm Beach County, Florida:
