CERTIFICATE OF AMENDMENT TO THE RESTATEMENT OF

ARTICLES OF INCORPORATION OF RIVERBEND GOLF CLUB, INC.

(f.k.a. Riverbend Owners Association, Inc.)



The Certificate of Amendment and Restatement of Articles of Incorporation was filed with the Secretary of State July 30, 1987. Articles of Amendment were filed February 22, 1989. The same Articles of Incorporation are hereby amended as approved by a vote sufficient for approval at the special member's meeting held on December 14, 2010.

1. Article III, (A) is hereby amended as follows:

ARTICLE III Members

(A) All persons who are owners of a condominium unit and are members of Riverbend Condominium Association, Inc. shall automatically be members of this corporation. Membership in this Corporation shall automatically terminate when such person is no longer the owner of a condominium unit in Riverbend Condominium. There shall be a maximum of One Hundred Sixty-Four (164) additional memberships besides the memberships designated to the Riverbend Condominium unit owners. The One Hundred and Sixty-Four (164) memberships shall be issued pursuant to the terms and requirements as set out in the By-Laws.

(Subparagraph (B) remains unchanged.)

- 2. The foregoing amendment to the Restatement of Articles of Incorporation was adopted by the members by a vote sufficient for approval.
- 3. All provisions of the Restatement of Articles of Incorporation are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
