ARTICLE I. The name of this Corporation shall be SLEEPY HOLLOW <u>FIRST</u> <u>ADDITION</u> HOMEOWNERS' ASSOCIATION, INC.

ARTICLE V. Section 2: The members of the Board of Directors shall be elected by written ballot for staggered terms of three two years by a majority vote of the members of the corporation present and entitled to vote at the annual meeting of the corporation at which quorum is present.
