Dear Chapter President:

One of the recent decisions by the AARP Board of Directors was the creation of an action plan for chapters to provide clarity about, and opportunities to strengthen, the organization's relationship with chapters. The two-year action plan begins with the AARP Board of Director's affirmation that chapters have been an important part of AARP's history, and will remain a significant component in the organization's future.

The action plan focuses on:

- Administration and Support—to upgrade customer service, strengthen the AARPchapter relationship, and resolve issues surrounding state filing requirements.
 - Leadership and Chapter Operations—to improve chapter effectiveness and test new approaches for supporting and developing chapter leadership.
- Communication and Recognition—to provide information through a comprehensive communications strategy and recognize chapter successes.

From this three-pronged approach, guidelines will be developed for the state and national level to determine how best to support existing chapters.

The purpose of this letter is to highlight the first part of the action plan agenda – Administration and Support. We will launch these activities by first confirming that chapters are in: "good standing" as:an incorporated entity in the state. Second, we are instituting a new policy that reflects the overall principle of the organization to be consistent in its identity. That is, chapters in good standing will change the name of the chapter from American Association of Retired Persons to AARP. Third, as a customer service upgrade, and to address issues regarding state filing obligations, the CT Corporation System (CT) will become the registered agent of record for all chapters, in good standing. This procedure will serve to maintain a high level of responsiveness with statutory requirements, and will ease the administrative burden on chapters.

Last year, CT was enlisted to determine the filing status of all chapters with their state. The audit produced a list of chapters in "good standing" and "not in good standing". Of course, we are aware that some of you expressed concerns about the previous audit process, and the accuracy of the information gathered. In response to those concerns, we have modified the audit procedures to minimize the paperwork involved in the completion of required forms and to ensure that we obtain the most precise and complete data possible.

Outlined below is more information about these procedures in anticipation of some of the questions that you and your chapter members may have as this process unfolds.
