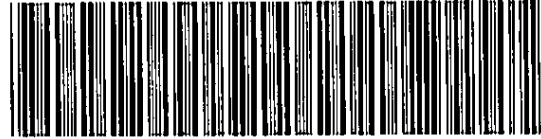

## **ARTICLES OF INCORPORATION**

### **In Compliance with Chapter 6174, F.S., (Not for Profit)**

#### **ARTICLE I- NAME**

The name of the Corporation shall be Oak Grove Church of the Apostolic Faith of New Smyrna Beach, Florida, Inc.

#### **ARTICLE II- PRINCIPAL OFFICE**

441 Sheldon St.

New Smyrna Beach, Florida 32168

#### **ARTICLE III-PURPOSE**

The Corporation is organized exclusively for charitable, religious, literary, and educational purposes, including for in-kind purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as section 501(c)(3) of the Internal Revenue Code 1986.

#### **ARTICLE IV - PROHIBITIONS**

1. No part of any earnings of the Corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons for any reason not authorized by the Board of Directors, except that the Corporation shall be authorized and empowered to pay reasonable, measurable, and verifiable competitive compensation for services rendered to the Corporation and to make payments and distributions in furtherance of the purposes.
2. No substantial part of the activities of Oak Grove Church of the Apostolic Faith of New Smyrna Beach, Florida shall be dedicated to, or otherwise, attempt to influence, United States State or Federal legislation, and the Corporation shall not participate or intervene in any political campaign on behalf of or in opposition to any candidate for public office.
3. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permissible (A) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code or (B) by a corporation, contributions to which are deductible under section 1: 70(c)(2) of the Internal Revenue Code.

#### **ARTICLE V - DIRECTORS**

The Directors shall be elected by a majority vote of the Members of this Corporation as defined by the process in the Bylaws of the Corporation.

#### **ARTICLE VI - TERM OF EXISTENCE**

This Corporation shall have perpetual existence.

#### **ARTICLE VII - CAPITAL STOCK**

This Corporation shall issue no capital stock and shall be composed of members rather than stockholders.

#### **ARTICLE VIII - QUALIFICATIONS OF MEMBERSHIP**

The categories of membership, qualifications for membership, and the manner of admission shall be as set forth in and regulated by the Bylaws of the Corporation.

#### **ARTICLE IX - VOTING RIGHTS**

Members of the Corporation will have such voting rights as are defined in the Bylaws of the Corporation.

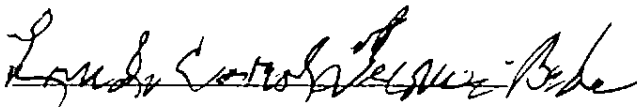
#### **ARTICLE XII - AMENDMENTS**

#### ARTICLE XIII - DISSOLUTION

Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or so disposed of shall be disposed of by Court of Competent Jurisdiction of the county in which the principal officer of the Corporation is then located, exclusively for such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

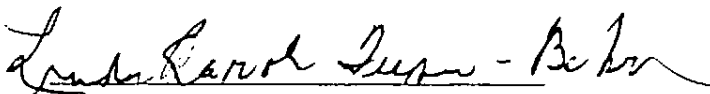

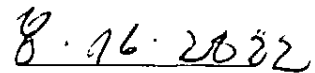
