ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF
NORTHLAND, A CHURCH DISTRIBUTED, INC.,
A FLORIDA NOT FOR PROFIT CORPORATION

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, **NORTHLAND, A CHURCH DISTRIBUTED, INC.**, a Florida not for profit corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is Northland, a Church Distributed, Inc.
2. The original Articles of Incorporation for the Corporation were filed on November 15, 1973 and assigned Charter No. 728026. The Articles of Incorporation were amended by that certain Articles of Amendment filed May 21, 1984. The Articles of Incorporation were then amended and restated by that certain Amended and Restated Articles of Incorporation filed July 29, 1999, and further amended by that certain Articles of Amendment to Articles of Incorporation filed April 19, 2005.
3. By a unanimous written consent executed on ~~March~~ ^{April} ~~_____~~ ⁹, 2024 by the directors, namely, the Board of Governing Elders of the Corporation, the Board of Governing Elders have approved, authorized and directed that the Articles of Incorporation of the Corporation shall be amended to change the name of the Corporation to "NORTHLAND CHURCH, INC." and the principal office address and mailing address of the Corporation be changed to 522 Dog Track Road, Longwood, Florida 32750. There are no members entitled to vote on the amendment, and the amendment was adopted by the Board of Governing Elders of the Corporation.

4. Article I of the Articles of Incorporation is hereby amended to read as follows:

ARTICLE I - NAME

The name of this Corporation shall be NORTHLAND CHURCH, INC.

5. Article II of the Articles of Incorporation is hereby amended to read as follows:

ARTICLE II - ADDRESS OF PRINCIPAL OFFICE
AND MAILING ADDRESS OF THE CORPORATION

The principal place of business and the mailing address of the Corporation is 522 Dog Track Road, Longwood, Florida 32750.
