AMENDMENT TO THE ARTICLES OF INCORPORATION OF PALM GREENS AT VILLA DEL RAY RECREATION CONDOMINIUM ASSOCIATION, INC.

The original Amended By-Laws of Palm Greens at Villa Del Ray Recreation Condominium Association, Inc. are recorded in the Official Records of Palm Beach County as set forth on the Certificate of Amendment attached hereto.

As used herein, words <u>underlined</u> are added and words hyphened through are deleted.

ARTICLES OF INCORPORATION

Article 9.2 of the Articles of Incorporation of Palm Greens at Villa del Ray Recreation Condominium Association, Inc., as amended, shall be further amended to read as follows:

Amendment to these Articles of Incorporation will be proposed and adopted in the following manner:

(9.2) A resolution for the adoption of a proposed amendment may be proposed either by the Board of Directors or by the Sub-Association Representatives. Directors and representatives not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing such approval is delivered to the secretary prior to the meeting. Except as elsewhere provided, Such approvals must be by not less than 75% a majority of the entire membership of the Board of Directors and by not less than 75% a majority of the voting interests of the entire membership of Number 1 Condominium Association Palm Greens at Villa Del Ray, Inc., and a majority of the voting interests of the entire membership of Number 2 Condominium Association Palm Greens at Villa Del Ray, Inc., of all of the representatives of the Sub-Associations.
