CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF LEILANI HEIGHTS HOMEOWNERS ASSOCIATION, INC.

A Corporation Not-For-Profit Under the Laws of the State of Florida

The Articles of Incorporation of Leilani Heights Homeowners Association, Inc. were filed with the Florida Secretary of State on December 13, 1973. The same Articles of Incorporation were recorded in Official Records of Martin County, Florida at Official Records Book 770, Page 2427, et. seq. The same Articles of Incorporation are hereby amended as approved by the membership by vote sufficient for approval at the Annual Members Meeting held on November 25, 2008.

1. Article III, Section 3.2 is amended to read as follows:

ARTICLE III. POWERS

- 3.2 In addition thereto, the Association shall have all of the powers and duties set forth as follows:
- f) To make and amend reasonable regulations respecting the use of the Association property and lots located in Leilani Heights.
- g) To enforce by all and every legal means the provisions of these Articles, the Bylaws of the Association, and the Regulations for the use of the Association property and lots located in Leilani Heights.

(The balance of Section 3.2 remains unchanged)

- 2. The foregoing amendment to the Articles of Incorporation of Leilani Heights Homeowners Association, Inc. was adopted by the membership by a vote sufficient for approval at the Annual Members Meeting held on November 25, 2008.
- 3. The adoption of this amendment appears upon the minutes of said meeting and is unrevoked.
- 4. All provisions of the Articles of Incorporation of Leilani Heights Homeowners Association, Inc. are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
