## (Document Number 728408)

Pursuant to Section 617, 1006, Florida Statutes, this Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

[Additions are indicated by <u>underline</u>; deletions by strike through] adopted in the following manner:

If the proposed Amendment has been approved by the unanimous a majority (a) vote of the Board of Directors, then the Amendment shall require the approval of not less than sixty percent (60%) of the members owning a majority of the Association voting, in person or by proxy, at any meeting of the members of the Association at which a quorum has been attained units in the Condominium.

If the proposed Amendment has not been approved by the unanimous (b) majority vote of the Board of Directors, then the Amendment shall require the approval not less than sixty percent (60%) of the members of the Association voting, in person or by proxy, at any meeting of the members of the Association at which a quorum has been attained, owning of the Units in the Condominium.

(c) Any approved Amendment shall be recorded and certified as required by the Condominium Act.

The foregoing amendments to the Articles of Incorporation were duly adopted by the 2. corporation on April 20, 2021 at a duly noticed meeting of the members of the corporation.
