#### AMENDMENT TO

#### ARTICLES OF INCORPORATION

#### FOR

#### JACKSONVILLE SISTER CITIES ASSOCIATION, INC.

The Corporation is organized exclusively and shall be operated exclusively for charitable, scientific, literary or educational purposes within the meaning of Section 170(c)(2) and 501(c)(3) of the United States Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent tax laws. The Corporation shall not have or exercise any power or authority either expressly, by interpretation or by operation of law, nor shall it directly or indirectly engage in any activity, that would prevent it from qualifying (and continuing to qualify) as a corporation described in 501(c)(3) of the Internal Revenue Code.

The Corporation shall not carry on propaganda or otherwise attempt to influence legislation except to the extent permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code (as the same is now in effect or as it may hereafter be amended), nor shall it in any manner or to any extent participate in, or intervene in any political campaign, on behalf of or in opposition to any candidate for public office.

No part of the income or assets of the Corporation shall inure to any member, officer or director or be distributable to any such person during the life of the Corporation or upon its dissolution or final liquidation. Upon dissolution or final liquidation of the Corporation, after discharge or satisfaction of all outstanding obligations and liabilities, the remaining assets of the Corporation may be distributed in accordance with the determination of the Board of Directors of the Corporation for similar charitable or educational purposes or to or among one or more similar corporations organized and operated exclusively for charitable and educational purposes similar to those stated in these Article of Incorporation, within the meaning of the Internal Revenue Code, as the same is now in effect or as it may hereafter be amended.
