

CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF OCEANGATE OF VERO BEACH ASSOCIATION, INC.

A Not For Profit Corporation, Incorporated Florida, March 25, 1974

A Corporation Not-For-Profit Under the Laws of the State of Florida

The Articles of Incorporation of Oceangate of Vero Beach Association, Inc. were filed with the Florida Secretary of State on March 25, 1974. The same Articles of Incorporation vere recorded in Official Records of Indian River County, Florida at Official Records Book 461, Page 712 (as part of the Declaration recorded at Official Records Book 461, Page 675). Articles of Amendment were filed with the Florida Secretary of State on December 18, 1985. The same Articles of Amendment were recorded in Official Records Book 724, Page 1063. Oceangate of Vero Beach Association, Inc., by its duly authorized officers, hereby certifies that the amendment to these Articles was approved by the Membership by vote sufficient for approval at the Special Members' Meeting held December 6, 2018.

- 1. Article IX is amended to read as follows:
- 9.2 A resolution for the adoption of a proposed amendment may be proposed either by the Board of Directors or by a written petition executed by not less than twenty percent (20%) of the members of the Association; except as elsewhere provided.

Such proposed amendments must be approved by the affirmative vote of at least 75% of those members present and voting at a duly noticed meeting at which a quorum is established.

(The balance of Article IX remains unchanged)

- 2. The foregoing amendment to the Articles of Incorporation of Oceangate of Vero Beach Association, Inc. was adopted by the Membership by vote sufficient for approval at the Special Members' Meeting held on December 6, 2018.
- 3. All provisions of the Articles of Incorporation of Oceangate of Vero Beach Association, Inc. are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
