Section 5.1 of the Articles of Incorporation is amended to read as follows:

5.1 The affairs of the Association will be managed by a Board consisting of the number of Directors determined by the Bylaws, but not less than three (3) Directors, and in the absence of such determination shall consist of three (3) Directors. Directors need not shall be members of the Association.
