ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF GRENELEFE ASSOCIATION OF CONDOMINIUM OWNERS NO. 1, INC. OWNERS NO. 1, INC.

Pursuant to the provisions of section 617.1006, and Chapter 718, Florida LORIDA Statutes, this Florida Not for Profit Corporation adopts the following amendments to its Articles of Incorporation (NOTE: additions are identified by <u>underline</u> and deletions are identified by <u>strikethrough</u>, sections of text that remain unchanged but are not reprinted here are identified by ellipses * * *):

Section 1. ARTICLE 3 is amended as follows

3.2 The Association shall have all of the powers and duties set forth in the Condominium Act and all of the powers and duties reasonably necessary to operate the condominium pursuant to the Declarations and as they may be amended from time to time, including but not limited to the following:

* * *

f. To make and amend reasonable regulations respecting the use of the property in the condominium; provided, however, that all such regulations and their amendments except the initial regulations shall be approved by not less than 75% of the votes of the entire membership before such shall become effective. shall be approved In the same manner as amendments to the Articles of Incorporation.

Section 2. ARTICLE 9 is amended as follows:

Amendment to the Articles of Incorporation shall be proposed and adopted in the following manner:

- 9.1 Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.
- 9.2 A resolution for the adoption of a proposed amendment may be proposed either by the board of directors or by the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writhing provided such approval is delivered to the secretary at or prior to the meeting. Except as elsewhere provided,

- (a) Such approvals must be by not less than 66-2/3% of the entire membership of the board of directors and by not less than 66-2/3% of the votes of the entire membership of the Association; or
- (b) By not less than 80% of the votes of the entire membership of the Association.

Section 3. The foregoing amendments to were duly adopted by the Board of Directors and Membership of Grenelefe Association of Condominium Unit Owners, No. 1 on the 6th day of November 2010.

Section 4. These Amendments shall be effective upon filing with the Department of State.
