ATTACHMENT 1

Article VII (Amended)

PURPOSE AND TERMS OF DISSOLUTION. This corporation is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed to the Broward County Historic Preservation Board, a Certified Local Government (CLG) operated under the direction of the State of Florida, for similar purposes as set forth herein; in event that State Agency is unable or unwilling, or cannot so utilize such property, real, personal, or mixed, then such assets shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
