## RESTATED AND AMENDED ARTICLES OF INCORPORATION OF FIRST BAPTIST CHURCH IN THE PINES, INC. A FLORIDA NON-PROFIT CORPORATION

#### ARTICLE ONE

**NAME** 

The name of this corporation shall remain FIRST BAPTIST CHURCH IN THE PINES, INC.

#### **ARTICLE TWO**

**NON PROFIT STATUS** 

This is a non-profit Corporation organized solely for the general purposes pursuant to the Florida Corporation Not for Profit law set forth in Chapter 617 of the Florida Statutes.

#### ARTICLE THREE PURPOSE

- (a) The specific and primary purpose of which this corporation is formed is to operate for the advancement of Christianity as interpreted by the Southern Baptist denomination, charity and education and for other charitable purposes, by the distribution of its funds for such purposes and particularly for the Evangelistic Outreach Ministry.
- (b) The general purposes for which this Corporation is formed are to operate exclusively such religious, charitable and educational purposes as will qualify it as an exempt organization under 501 (c) (3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws, including for such purpose, the making of distributions to organizations which qualify as tax-exempt organizations under that Code.
- (c) This corporation is organized, in part for the purpose of holding the title to such property or purchase as the said FIRST BAPTIST CHURCH IN THE PINES, Nokomis, Florida shall, from time to time, purchase or acquire. The corporation shall have power, to make such contracts and to do such things as shall be authorized and directed by the members of said FIRST BAPTIST CHURCH IN THE PINES, Nokomis, Florida. This corporation shall have no power to mortgage, sell, encumber, deed or otherwise dispose of any property without the written consent and direction of the said FIRST BAPTIST CHURCH IN THE PINES, Nokomis, Florida, evidenced by resolution of said FIRST BAPTIST CHURCH IN THE PINES, Nokomis, Florida duly passed.

#### ARTICLE FOUR DURATION

This Corporation shall have a perpetual existence and these RESTATED AND AMENDED ARTICLES OF INCORPORATION are to take effect immediately.

#### ARTICLE FIVE DIRECTORS

There shall be three (3) members of the initial Board of Directors of the corporation. This corporation, however, reserves the right and power to increase and decrease the number of Directors as provided in the Bylaws of FIRST BAPTIST CHURCH IN THE PINES, Nokomis, Florida and/or by appropriate action of its members, but the number of Directors shall never be less than three (3).

Upon dissolution or winding up of the Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation, shall be distributed to the Florida Baptist Convention consistent with the requirements of the restrictive covenant contained in the FIRST BAPTIST CHURCH IN THE PINES, Nokomis, Florida deed.

#### ARTICLE FOURTEEN AMENDMENTS

Amendments to the Articles of Incorporation may be adopted by the same process spelled out in the then-existing By-laws of the said FIRST BAPTIST CHURCH IN THE PINES, Nokomis, Florida, whereby the By-laws of the said FIRST BAPTIST CHURCH IN THE PINES, Nokomis, Florida may be amended.


