AMENDMENT TO ARTICLES OF INCORPORATION ON S

OF

RIVERSIDE-AVONDALE PRESERVATION, INC.

DOCUMENT NUMBER 729918

1. Article V of the Articles of Incorporation of Riverside Avondale Preservation, Inc. are hereby amended in its entirety as follows.

ARTICLE V

MANAGEMENT

The affairs of the Corporation shall be managed by a Board of Directors. The Board of Directors shall consist of at least three (3) members, having the qualifications set forth in the Bylaws. The Board shall be chosen by the membership of the Corporation for a term and in a manner set forth in the Bylaws of the Corporation. A quorum for purposes of a Board meeting shall consist of one-third (1/3) of the prescribed number of directors under the Bylaws. Any director of the Corporation may be removed at any time with or without cause by a vote of more than one half of all the members of the Corporation and in accordance with the Florida Not For Profit Corporations law.

The Corporation shall have such officers as the Board of Directors shall determine: provided, however, that it shall have a Chairperson who shall serve as the Chief Executive Officer of the Corporation, a Vice Chairperson, a Treasurer, a Legal Officer, and a Secretary. The officers shall be chosen by the Board of Directors for a term and in a manner as set forth in the Bylaws of the Corporation. Any officer or director of the Corporation may be removed at any time with or without cause by a vote of two thirds (2/3) of all the members of the Board of Directors. The Bylaws may create an executive committee to manage the affairs of the Corporation in the interim period between meetings of the Board of Directors.

2. There are no members entitled to vote on this amendment. The foregoing amendment was adopted by the Board of Directors of this Corporation on July 16, 2008.
