KNOW ALL MEN BY THESE PRESENTS that the undersigned, CANTERBURY INC., a Florida corporation not for profit, does hereby amend the Declaration of Condominium of CANTERBURY APARTMENTS, a Condominium, recorded at OR Book 1083, Pages 1052 through 1090, inclusive, of the Public Records of Sarasota County, Florida, as follows:

Paragraph 20.4 of the Declaration of Condominium of CANTERBURY APARTMENTS, a Condominium, is hereby amended in its entirety to read as follows:

No owners, renters, or visitors shall be allowed to have any pets, excepting only those owners or renters who already had pets as of the effective date of this Amendment. Upon death or other disposal of any such existing pets, they shall not be replaced.

This Amendment shall become effective upon being recorded in the Public Records of Sarasota County, Florida, as provided by law.
