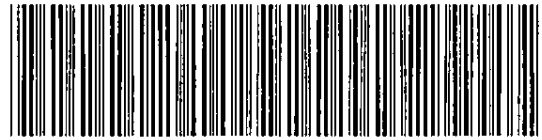

ARTICLES OF INCORPORATION

GULF COAST GOLF COURSE SUPERINTENDENTS ASSOCIATION, INC.

A CORPORATION NOT FOR PROFIT

FIRST: The name of this corporation is Gulf Coast Golf Course Superintendents Association, Inc.

SECOND: Its principal office and place of business in the State of Florida is to be located at 314 South Baylen Street in the City of Pensacola, Florida, and the resident agent in charge thereof is Stanley Files, 314 South Baylen Street, Pensacola, Florida 32501.

THIRD: The purposes for which this corporation is formed are:

- (a) To advance the art and science of golf course maintenance, to cement the golf course superintendents in this area into a closer relationship with each other, to collect and disseminate practical knowledge of the problems of golf course maintenance with a view to more efficient and economical operations.
- (b) To promote a better relationship between the superintendent and his club members and his officers.
- (c) To create and improve a cooperative effort to collect, disseminate and preserve scientific and practical knowledge for the more efficient and economical maintenance of golf courses in this area and other areas where conditions are similar.
- (d) To establish a program of education and training whereby the profession and position of the superintendents will be promoted and protected.
- (e) To encourage and actively participate in turf research programs, experimental projects, and demonstrations whenever and wherever possible.

FOURTH: This corporation shall be a corporation not for profit and shall not have any capital stock. The conditions, qualifications, privileges and obligations of membership shall be as set forth in the By-laws of the corporation. Provision may also be made by the By-laws for one or more classes of members who shall have no voting power.

FIFTH: The names and places of residence of each of the incorporators of the corporation are as follows: Stanley Files, 314 South Baylen Street, Pensacola, Florida 32501; Charles V. Rettew, Route 8, Box 695, Pensacola, Florida 32506; and William M. Norrie, 314 South Baylen Street, Pensacola, Florida 32501.

FIFTH-A: The membership shall be persons currently employed on golf courses for maintenance purposes as superintendents or assistant superintendents or in line for such positions and shall be of good moral character, over the age of 18 years. The classes of membership may be divided and provided by the By-laws for qualifications based on experience and length of service.

FIFTH-B: The By-laws of the corporation shall be originally made, adopted and approved by the stockholders and may thereafter be altered or rescinded by a majority vote of the stockholders or by a unanimous vote of the Board of Directors.

SIXTH: The corporation shall have perpetual existence.

SEVENTH: The private property of the members shall not be subject to the payments of corporate debts or liabilities to any extent whatever.

EIGHTH: BOARD OF DIRECTORS: The Board of Directors shall be not less than three nor more than nine in number. The business of the corporation shall be managed by the Board of Directors and the officers of the corporation.

The Board of Directors shall have full power to act within its discretion in the performance of the objectives of the association for its benefit and that of its members; shall have supervision over the officers of the association and shall supervise the expenditure of monies paid into its treasury and shall have full authority to act in all matters not inconsistent with the certificate of incorporation, the general law or the By-laws.



NINTH: The meetings of the members and of the Board of Directors shall be held at any place within or without the State of Florida as provided by the By-laws and the corporation shall keep the books subject to the provisions of the Statutes of the State of Florida and at such places as from time to time may be designated by the Board of Directors.

TENTH: The Certificate of Incorporation of this corporation may be amended if two-thirds of the whole number of the Board of Directors at a meeting thereof shall adopt a resolution declaring that the amendment is advisable and shall vote in favor of such amendment and if such amendment shall be adopted by two-thirds of the members of this corporation present or represented by delegates or proxies and entitled to vote at the next annual meeting of this corporation held after the adoption of such resolution and such vote by the Board of Directors.

ELEVENTH: Provision may be made in the By-laws of the association for the representation of voting members, with their consent, at any annual or special meeting, by the delegate of the chapter of this association to which such members belong, in lieu of their voting in person or by proxy; provided, that members may be represented by a chapter delegate for voting purposes only with respect to amendments to the certificate of incorporation and to the by-laws of this association and to the election of officers and directors thereof.

TWELFTH: The first officers of this corporation who shall hold office until their successors are duly elected as provided by the By-laws are as follows: President, Stanley Files; Vice President, Charles V. Rettew; Secretary-Treasurer, William M. Norrie.

THIRTEENTH: The first Board of Directors of this corporation are as follows and shall hold office until their successors are duly qualified and elected as provided by the By-laws: Stanley Files, Pensacola, Florida; Charles V. Rettew, Pensacola, Florida; William M. Norrie, Pensacola, Florida; James E. Hughes, Fort Walton Beach, Florida; Paul C. Green, Atmore, Alabama.

We, the undersigned, for the purpose of forming a corporation, not for profit, under the laws of the State of Florida, and pursuant to the State of Florida not for profit corporation act, Chapter 617 of the Florida Statutes, do make and file this certificate and declare
