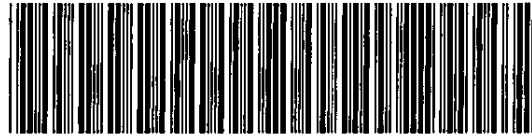

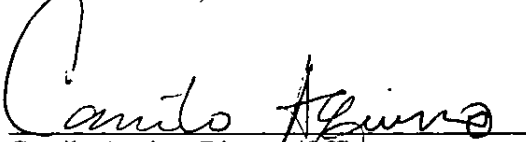

The amendment was adopted by the Board of Directors. There are no members entitled to vote on the amendment.

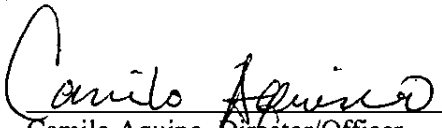

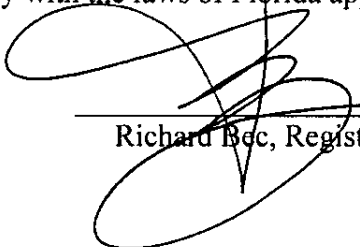
