ARTICLES OF AMENDMENT
OF
BAHIA VISTA MENNONITE CHURCH, INC.

Pursuant to Section 617.1006, Florida Statutes, the Articles of Incorporation of Bahia Vista Mennonite Church, Inc., a Florida not-for-profit corporation (the "Corporation"), as amended, formed on August 26, 1974, and assigned document number 730535, are hereby amended as follows:

1. Article I of the Articles of Incorporation is hereby stricken in its entirety and replaced with the following:

ARTICLE I

NAME

The name of the Corporation shall be SARASOTA COMMUNITY CHURCH, INC., and for convenience the Corporation shall be referred to in this instrument as the Church.

2. Article II of the Articles of Incorporation is hereby stricken in its entirety and replaced with the following:

ARTICLE II

PURPOSE

The purpose for which this Corporation is organized is to administer the business and spiritual affairs of the congregation of the Sarasota Community Church, whose purposes are to own and maintain a place of worship for the congregation of the Church, to educate and inform the members of the Church and the general public as to the tenants and teachings of the Church, and to make from time to time, charitable and educational grants and contributions, to receive donations, bequests and contribution from members and from the general public, and for all other religious, charitable and beneficent purposes.

The Church shall make no distributions of income to its members, directors, or officers.
