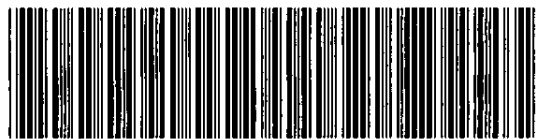

Special Business Meeting
October 14, 2009

Pastor Mark addressed the congregation concerning changing the name of the church.

He reiterated the fact that we are not leaving the Assemblies of God. And that the Assemblies of God District Office is supportive.

It is not mandated that A/G be in the name.

Pastor shared some scriptural references to name changes and how he believes God is moving in this church.

Many churches and Assemblies have changed names. Many ministries have changed their names such as, Missionettes to Mpact, CA's to Extreme Youth.

We were the First Assembly of God simply because we were the 1st church of the Assemblies of God in this area.

Pastor shared reference from 1 Corinthians.

Pastor addressed questions.

The church membership roll was read by the secretary.

Motion to accept the membership as presented was made and seconded, motion passed unanimously.

Ballots were passed out. Pastor made the decision to allow a ballot vote even though a unanimous yea/nay was expectable.

129 members were present meeting the quorum of 68 required.

Votes were counted and the church agreed by majority to change the name of the church to Life Point Church, of the Assemblies of God.

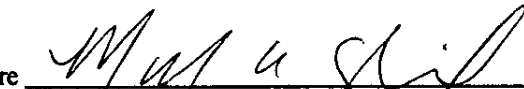
