




GOOD NEWS FELLOWSHIP CHURCH, INC., a Florida Not-For-Profit corporation,
executes the following Articles of Dissolution pursuant to Section 617.1403 of the Florida
Business Organization Act;

- FIRST: The name of the corporation is GOOD NEWS FELLOWSHIP CHURCH, INC., (the "Corporation").
- SECOND: The not-for-profit Corporation is governed by its Elders and Board of Directors and no member has any voting rights.
- THIRD: On the 10th day of June, 2008, the Elders and Board of Directors unanimously approved the dissolution of the Corporation which was executed in accordance with the law.
- FOURTH: The Corporation's assets remaining after winding up the Corporation's affairs will be distributed according to the plan of distribution attached hereto as Exhibit "A", and the effective date of the Articles of Dissolution shall be the 10th day of June, 2008.

The undersigned, constituting the Elders and all members of the Board of Directors of the Corporation have executed these Articles of Dissolution this 10th day of June, 2008.

**PLAN OF DISTRIBUTION OF ASSETS
OF GOOD NEWS FELLOWSHIP CHURCH, INC.**

Pursuant to Florida Statutes Section 617.1406, the Good News Fellowship Church, Inc., a Florida not-for-profit corporation (the "Corporation") hereby sets forth its plan of distribution of assets after a vote of the Elders and Board of Directors of the Corporation to dissolve the Corporation, which meeting was held on the 10th day of June, 2008.

The decision to dissolve the Corporation being made unanimously by the Elders and the Board of Directors was promulgated to implement a plan of distribution of the assets by addressing the corporate business as follows:

FIRST: Liabilities: All liabilities and obligations of the Corporation have been paid and discharged or adequate provisions have been made to do so in the ordinary course of business


SECOND: Assets:

- a. That certain Mortgage Deed dated May 31, 2007, by and between Ministerio Cristo Te Ama, Inc., as Mortgagor, and Good News Fellowship Church, Inc., as Mortgagee, as further modified on the 18th day of July, 2008, shall be assigned to the National Christian Foundation's real estate holding company, National Christian Foundation Real Property, Inc., a Georgia non-profit corporation, with oversight by the Christian Community Foundation of South Florida, Inc., ("CCFSF") for the use and benefit of worthy Christian congregations located in South Florida at the discretion of CCFSF, with advise from James R. Wolfe and Ragnhild K. Ulrich.
- b. All cash and corporate bank accounts (corporate funds) shall be expended for any administrative costs in winding down the affairs of the Corporation, paying those existing liabilities in the ordinary course of business with the remainder of the corporate funds being turned over to the National Christian Foundation through the CCFSF for the use and benefit of worthy Christian congregations located in South Florida, at the discretion of CCFSF with advice from James R. Wolfe and Ragnhild K. Ulrich.


THIRD: A copy of this Plan of Distribution of Assets, authenticated by the Secretary of the Corporation, evidencing its compliance with the requirements of Florida Statutes 617.1406 shall be filed with the Department of State for the State of Florida pursuant to law.






