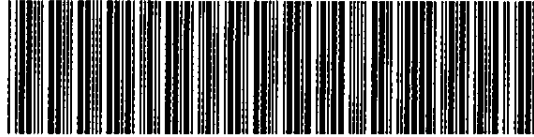

**ARTICLES OF AMENDMENT TO ARTICLES  
OF INCORPORATION OF  
CAPE CORAL SOCCER ASSOCIATION, INC.**

Pursuant to the provisions of Fla. Stat. 617.1006, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

Amendment adopted: Article V amended as follows:

**ARTICLE V**

Anything in these articles of incorporation to the contrary notwithstanding, the purpose or purposes for which this corporation is organized are limited to those that will qualify it as an exempt organization under 26 U.S.C.A. Section 501(c)(3), including, for those purposes, the making of distributions to organizations that qualify as tax-exempt organizations under the Internal Revenue Code.

This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation. This corporation shall not participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office.

No part of the net earnings, properties, or assets of this corporation, on dissolution or otherwise, shall inure to the benefit of any private person or individual or any member or director of this corporation. On liquidation or dissolution all properties and assets of this corporation remaining after paying or providing for all debts and obligations shall be distributed and paid over to a fund, foundation, or corporation organized and operated for charitable or religious purposes designated by the board of directors which shall at the time qualifies as a tax-exempt organization under 26 U.S.C.A. Section 501(c)(3), or as that statute may be amended.

The date of adoption of the amendment was: February 5, 2007.
