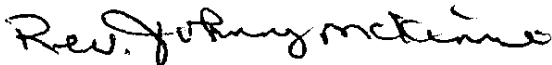

After not hearing from us, your office filed an Administrative Dissolution on 9/21/2001. In a conversation with your office, we were advised that the Reinstatement Form rather than three UBR forms should be submitted to your office with a fee of one hundred eighty-three dollars and seventy-five cents (\$183.75) to cover the costs of the annual filing fees and the copies of The Certificates of Status.
