# PROPOSED AMENDMENTS TO ARTICLES OF INCORPORATION AND BY-LAWS OF BAYWAY ISLES - POINT BRITTANY SIX CORPORATION, INC.

1. Proposed amendment to Articles of Incorporation, Article VIII, as follows:

## ARTICLE VIII BOARD OF DIRECTORS

The Board of Directors shall consist of five (5) or seven (7) persons, who shall be elected in the manner and for the terms set forth in the Bylaws of the Association...

2. Proposed amendment to By-Laws, Article IV, Section 1) (a), as follows:

## ARTICLE IV DIRECTORS

- 1) Directors and Election.
  - (a) The Board of Directors shall consist of five (5) or seven (7) members elected for a term of two years.
