#### PLAN OF MERGER

Merger betwen PATHWAYS FOR YOUTH AND FAMILY SERVICES, INC., a Florida Not-for-Profit corporation ("PATHWAYS") and OUTREACH BROWARD, INC., a Florida Not-for-Profit corporation ("OUTREACH").

This Merger is being effected pursuant to this Plan of Merger ("Plan"), in accordance with Section 617.1101 of the Florida Not-for-Profit Corporation Act (the "Act").

- 1. Articles of Incorporation. The Articles of Incorporation of OUTREACH, as in effect immediately before the Effective Date, shall be the Articles of Incorporation of the surviving corporation until further amended as provided by law.
- 2. <u>Effect of Merger.</u> On the Effective Date, the separate existence of PATHWAYS shall cease and OUTREACH shall be fully vested in all of PATHWAYS' property, or any interest therein, and shall be responsible and liable for all of the liabilities, obligations and duties of PATHWAYS, all as more particularly set forth in Section 617.1106 of the Act.
- 3. <u>Supplemental Action</u>. If at any time after the Effective Date OUTREACH shall determine that any further conveyances, agreements, documents, instruments, and assurances or any further action is necessary or desirable to carry out the provisions of this Plan, the appropriate officers of OUTREACH or PATHWAYS, as the case may be, whether a past or remaining in office, shall execute and deliver, on the request of OUTREACH, any and all proper conveyances, agreements, documents, instruments, and assurances, and perform all necessary or proper acts to vest, perfect, confirm or record such title thereto in OUTREACH, or to otherwise carry out the provisions of this Plan.
- 4. Filing with the Secretary of State and Effective Date. OUTREACH and PATHWAYS shall cause their respective President (or Vice President) to execute Articles of Merger in the form attached to this Agreement, and upon such execution this Plan shall be deemed incorporated by reference into the Articles of Merger as if fully set forth in such Articles and shall become an exhibit to such Articles of Merger. Thereafter, such Articles of Merger shall be delivered for filing by OUTREACH to the Florida Secretary of State. In accordance with Section 617.1105 (4) of the Act, the Articles of Merger shall specify the "Effective Date" which shall be January 1, 1998.
