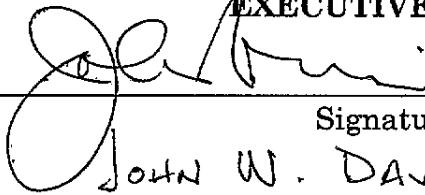
**FIRST:** Amendment adopted:
