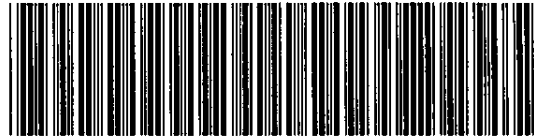

AMENDED AND RESTATED ARTICLES OF INCORPORATION OF THE ROCK OF PANAMA CITY, FLORIDA

The original Articles of Incorporation of the Corporation were filed on November 20, 1974, were amended by the Articles of Amendment to the Articles of Incorporation filed on October 4, 1984, were further amended by Articles of Amendment to the Articles of Incorporation on February 23, 1987.

ARTICLE I. NAME

The name of this church shall be The Rock of Panama City, Inc., of the City of Panama City, State of Florida.

ARTICLE II. PRINCIPLE OFFICE

The street address of the principle office and the mailing address of the principle office is 2413 Harris Avenue, Panama City FL 32405.

ARTICLE III. PURPOSE

For the purpose of establishing and maintaining a place for the worship of Yahweh, the Almighty God, our Heavenly Father; to provide for the fellowship of those who have been reconciled to Yahweh through a personal faith in and reliance upon Yahshua, the Anointed One, as Savior and Lord; to provide a place where Holy Spirit may be recognized and welcomed to manifest Himself by and through whatever gifts, and signs, and wonders He chooses; to provide for the discipling of each person toward maturity in Christ; and to assume our share of the responsibility and the privilege of propagating the Gospel of the Kingdom of Yahweh into all the world, we who are the present Body of Believers joined to the leadership and vision of this house, having demonstrated the same by our personal and individual testimony of faith in Yahshua, by having been baptized in His name for the remission of sins, by our faithfulness to attend its meetings, participate in its ministries, and support it faithfully with our tithes and offerings, and whose signatures appear on this document, do hereby recognize ourselves as a local church with all of the rights and privileges of governing itself according to the Holy Bible, the Word of Yahweh, and the laws of the State of Florida.

ARTICLE IV: MANNER OF ELECTIONS

Section 1. Senior Elder. The overseer of this church shall be a person whose giftings, graces, and anointing mark him as being of the five-fold ministry (apostle, prophet, evangelist, pastor, teacher) and shall occupy the position of Senior Elder either by virtue of having established this church, or by having been set in this position by action of the resident and non-resident elders. The Senior Elder shall be fully responsible for establishing and maintaining the vision of this church; he shall have full authority in the day to day life, ministry, and activities of this church.

Section 2. The Presbytery. The Senior Elder, together with all other full-time elders (those called into one of the five-fold ministry offices--apostle, prophet, evangelist, pastor, teacher) shall constitute The Presbytery. In keeping with our present understanding of New Testament Church order, The Presbytery, always acting under the leadership and direction of The Senior Elder, shall provide the vision, the spiritual ministry, the spiritual leadership, and the governmental oversight of this church. Serving in this capacity, they are understood to be the elders of the church.

Section 3. Corporation Officers/Directors. For the purpose of fulfilling the offices required by its corporation charter, The Senior Elder shall serve as the President of the corporation and will appoint the Vice-President and Secretary/Treasurer from the members of The Presbytery. All bank accounts (including investment accounts) will require the Senior Elder, Vice-President, and Secretary to be in agreement as to changes, withdrawals, or moving of funds.

Section 4. Non-Resident Elders. For the purpose of providing outside counsel to which any elder may appeal with regard to any matter of controversy involving that elder and The Senior Elder, and for the purpose of providing outside counsel to assist The Presbytery whenever it is necessary to select a person to fill the vacancy of The Senior Elder's position, there shall be a committee of three (3) Non-Resident Elders.

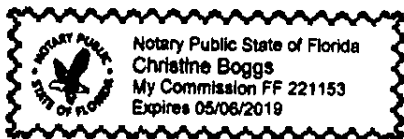
