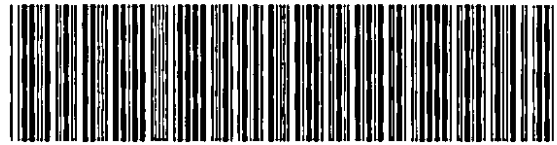

AMENDED AND RESTATED ARTICLES OF INCORPORATION OF

THE ROCK OF PANAMA CITY, INC.

ARTICLE I. NAME

The name of this church shall be Tribe Church, Inc., of the City of Panama City, State of Florida.

ARTICLE II. PRINCIPLE OFFICE

The street address of the principle office and the mailing address of the principle office is: 2413 Harris Avenue, Panama City FL 32405.

ARTICLE III. PURPOSE

For the purpose of establishing and maintaining a place for the worship of Yahweh, the Almighty God, our Heavenly Father; to provide for the fellowship of those who have been reconciled to Yahweh through a personal faith in and reliance upon Yahshua, the Anointed One, as Savior and Lord; to provide a place where Holy Spirit may be recognized and welcomed to manifest Himself by and through whatever gifts, and signs, and wonders He chooses; to provide for the discipling of each person toward maturity in Christ; and to assume our share of the responsibility and the privilege of propagating the Gospel of the Kingdom of Yahweh into all the world, we who are the present Body of Believers joined to the leadership and vision of this house, having demonstrated the same by our personal and individual testimony of faith in Yahshua, by having been baptized in His name for the remission of sins, by our faithfulness to attend its meetings, participate in its ministries, and support it faithfully with our tithes and offerings, and whose signatures appear on this document, do hereby recognize ourselves as a local church with all of the rights and privileges of governing itself according to the Holy Bible, the Word of Yahweh, and the laws of the State of Florida.

ARTICLE IV: MANNER OF ELECTIONS

Section 1. Senior Minister. The overseer of this church shall be a person whose giftings, graces, and anointing mark him as being called by Yahweh into the ministry and shall occupy the position of Senior Minister. The Senior Minister shall be fully responsible for establishing and maintaining the vision of this church; he shall have full authority in the day to day life, ministry, and activities of this church.

Section 2. The Presbytery. The Senior Minister, together with all other full-time Ministers shall constitute The Presbytery. The Presbytery shall constitute members of the Leadership Team, as appointed and recognized by the Senior Minister. In keeping with our present understanding of New Testament Church order, The Presbytery, always acting under the leadership and direction of The Senior Minister, shall provide the vision, the spiritual ministry, the spiritual leadership, and the governmental oversight of this church. Serving in this capacity, they are understood to be the Ministers of the church.

Section 3. Corporation Officers/Directors. For the purpose of fulfilling the offices required by its corporation charter, The Senior Minister shall serve as the President of the corporation. He will appoint officers and/or directors from the Presbytery or Board of Advisors.

Section 4. Non-Resident Minister(s). The Non-Resident Minister(s) shall be named and recognized by the Senior Minister. This person(s) shall provide Apostolic oversight and counsel to the Senior Minister. The Non-Resident Minister(s) shall be available for the purpose of providing outside counsel to assist the The Presbytery whenever it is necessary, including to select a person to fill the vacancy of The Senior Minister's position, should that need arise. A Non-Resident Minister shall be someone who is not presently serving on The Presbytery. The Non-Resident Minister(s) shall serve only as counsel, and that by request; they shall have no final authority in any matter.
