


ARTICLE II - PURPOSES

The corporation is organized exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code (or the corresponding portions of any future United States Internal Revenue Law), including, to the extent permitted by said Section 501(c)(3), the improvement, development, redevelopment, promotion, and upgrading of economic opportunities and the cultural, historical, and social environment existing or available to economically and socially disadvantaged persons and areas within the States of Florida and Alabama, with emphasis on the creation of opportunities for employment, business ownership, and affordable housing, including to foster and provide low-income housing and other services on a not-for-profit basis.

No substantial part of the activities of the Corporation shall be the carrying on or propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office.

This corporation is and shall remain a corporation not for profit. The Corporation shall not have nor issue shares of stock. No dividends shall be paid, and no part of the net earnings of the Corporation shall inure to the benefit of its members, directors or officers, to the benefit of any private shareholder or individual.
