Robert L. Holt Sr.- Minister and President

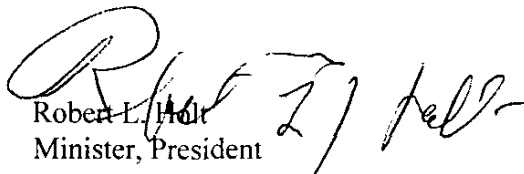
Charlie McSwain- Assistant Minister and Deacon
