O7 JUN 19 PM 12: 1 ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF WAVECRESTER CONDOMINIUM, INC.

Pursuant to the provisions of §617.1006, Fla. Stat., Wavecrester Condominium, Inc. ("Association") adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: Amendment adopted:

Article III, Section (e), Article VI, and Article XIV of the Articles of Incorporation of Wavecrester Condominium, Inc. are hereby amended as follows (additions-are indicated by <u>underlining</u>; deletions are indicated by <u>strike-outs</u>, omitted and unaltered provisions are indicated by ellipses):

ARTICLE III

The Association shall have all the powers and duties set forth in the Condominium Act, except as limited by these Articles and the Declaration of Condominium, and all of the powers and duties reasonably necessary to operate the condominium pursuant to the Declaration and as it may be amended from time to time, including but not limited to the following:

(e) To enforce the provisions of said Declaration of Condominium, these Articles of Incorporation, the By-Laws of the Association which may be hereafter adopted, and the rules and regulations governing the use of the condominium as same may be hereafter established. To make and amend reasonable regulations respecting the use of the Condominium property, in the condominium; provided, however, that all such regulations and their amendments shall be approved by not less than 75% of the votes of the entire membership of the Association before such shall become effective real and personal, so long as such regulations or amendments thereto do not conflict with the restrictions and limitations which may be placed upon the use of such property under the terms of the Bylaws and Declaration of Condominium.

ARTICLE VI

The principal office of the Association shall be located at 1520 S. Babcock Street, Melbourne, Florida, 301 S. Miramar Avenue, Indialantic, Florida, 32903-8133, but the Association may maintain offices and transact business in such other places within or without the State of Florida as may from time to time be designated by the Board of Directors.

ARTICLE XIV

Any amendment or amendments to these Articles of Incorporation may be proposed by the Board of Directors of the Association acting upon a vote of the majority of the Directors, or by the members of the Association owning a majority of the apartment units in the condominium, whether meeting as members or by instrument in writing signed by them. Upon any amendment or amendments to these Articles of Incorporation being proposed by said Board of Directors or members, such proposed amendment or amendments shall be transmitted to the President of the Association or other officer of the Association in the absence of the President, who shall thereupon call a special meeting of the members of the Association for a date not sooner than twenty (20) days and not later than sixty (60) days from the receipt by him of the proposed amendment or amendments, and it shall be the duty of the Secretary to give each member written or printed notice of such meeting, stating the time and place of the meeting and reciting the proposed amendment or amendments in reasonably detailed form, which notice shall be mailed or presented personally to each member not less than ten fourteen (10 14) days nor more than thirty (30) days before the date set for such meeting. If mailed, such notice shall be deemed to be properly given when deposited in the United States Mail, addressed to the member at his post office address as it appears on the records of the Association, the postage thereon prepaid. Any member may, by written waiver of notice signed by such member, waive such notice, and such waiver, when filed in the records of the Association, whether before or after the holding of the meeting, shall be deemed equivalent to the giving of such notice to such member. At such meeting the amendment or amendments proposed must be approved by an affirmative vote of twothirds (2/3) of the members owning not less than 75% of the apartment units in the condominium in order for such amendment or amendments to become effective voting in person or by proxy at any regular or special meeting of the members called and noticed in accordance with this section and Florida law (i.e., once a quorum is established at any regular or special meeting of the membership, two-thirds (2/3) of the members who are entitled to vote and who are present in person or by proxy may amend these Articles of Incorporation). Thereupon, such amendment or amendments of these Articles shall be transcribed and certified in such form as may be necessary to register the same in the office of the Secretary of State of Florida; and upon the registration of such amendment or amendments with said Secretary of State, a certified copy thereof shall be recorded in the Public Records of Brevard County, Florida, within ten (10) days from the date on which the same are so registered. At any meeting held to consider such amendment or amendments of these Articles, the Written vote of any member of the Association shall be recognized, if such member is not in attendance at such meeting or represented thereat by proxy, provided such written vote is delivered to the Secretary of the Association at or prior to such meeting.

Notwithstanding the foregoing provisions of this Article XIV, no amendment or amendments to these Articles abridging, amending or altering when the first election of Directors shall be held as provided in Article VII hereof, may be adopted or become effective without the prior written consent of WAVECREST VENTURE, INC., a Florida corporation.

SECOND: The date of adoption of the Amendment was the // day of February, 200 7.

THIRD: Adoption of Amendment:

Article XIV of the Articles of Incorporation of Wavecrester Condominium, Inc., in effect prior to the adoption of the instant amendment, provided that Amendments to the Articles of Incorporation may be approved by the affirmative vote of the members owning not less than 75% of the apartment units in the condominium.

The members of the corporation were entitled to vote on the Amendment. The members of the Association duly adopted the Amendment in accordance with the above-stated provision. The number of votes cast for the Amendment was sufficient for approval.
