

Restatement of Articles of Organization of Shockley Hill Club Inc



Article I Name of Corporation

The name of this corporation shall be Shockley Hill Club Inc. This will exist as a perpetual non-profit corporation under the laws of the state of Florida, with a permanent physical address of 20325 Blue Wing Rd, Altoona, Florida 32702

Article II Objectives

This organization will function as a social and recreational club that promotes fellowship and good community relations, as well as makes charitable donations, and sponsors charitable events for the community.

Article III Member Qualifications

Adults, both full time and part time, residing in the community of Shockley Hill or any of the Shockley communities, as well as any other neighboring communities, shall be eligible to join as long as they are individuals in good standing and pay membership dues each year. Immediate family members of any member, regardless of residence, may also hold membership. In addition, former residents, who were members of the club may continue their memberships as long as dues are paid each year.

Article IV Officers and Elections

The board will be comprised of the offices of President, Vice-President, Treasurer, Secretary, and two trustees. The term of office shall be for four years with elections being held in January. All nominees must be seconded. Present board members may rerun for office, if nominated and seconded.

Officers must be paid up members and residents of Shockley Hill, and either the President or the Vice President must be a full time resident.

Trustees need only to be paid up members who live in one of the Shockley or neighboring communities. Duties for each office and trustees shall be set forth by the board.

Article V Meetings

Regular meetings, as set by the board, will be held at a minimum of six times per year.

Article VI Dues

Annual dues will be payable January 1 of every year with a 90 day grace period. The amount will be set by the board.

Article VII Constitution

This constitution may be amended by the board and voted on by the members. A 2/3 majority vote will be needed to pass and amended articles must be filed with the state in order to be valid.

The board may draw up additional rules for the club in order to ensure the safety of the club and its members. These rules will be discussed and voted on by the members at regular meetings. Such rules will be posted on the bulletin board for all to see.
