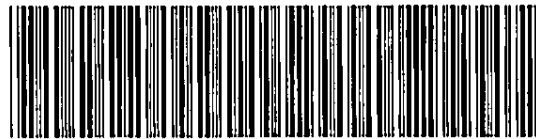

Article III Section 3 amended dates : The Annual Dues for active members shall be forty-five dollats(\$45) payable by
June meeting. Such dues shall be delinquent after the July meeting.

Article IV Section 2. G amended date: The Treasurer shall have all fiscal records ready for audit no later than forty-five (45)
days after the close of the fiscal year July 1 through June 30.

Article IV section 4 Amended dates : Election of Officer will be held at the May general Meeting (every two years).
Elections shall be by ballot, prepared by the nominating Committee, which shall collect and count ballots.

Article IV Section 5 Amended dates: The terms of office shall be for not more than two (2) consecutive years or
until her successor is elected. The installation of officers shall be in June, fiscal year end.

Article V Section I: Amended to add : Regular Business Meeting shall be held on the fourth Thursday of each month;
year round. A majority shall constitute a quorum at all meetings.


