

## ADOPTED ARTICLE OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF ENVOY POINT CONDOMINIUM ASSOCIATION, INC.

Adopted amendment to ARTICLE V, V.1 of the Articles of Incorporation of Envoy Point Condominium Association, Inc., to read as follows:

### ARTICLE V ADMINISTRATORS

V1.
