Article XVI. of the Articles of Incorporation is amended as follows:

Article XVI. For those actions which, by the provisions of the preceding Articles, require a vote of the Members, there must be a duly held meeting. Written notice, setting forth the purpose for the meeting shall be given to all Members not less than 30 days nor more than 60 days in advance of the meeting.

The presence of members or proxies entitled to cast ten per cent (10%) thirty percent (30%) of the votes of each class of membership shall constitute a quorum. If the required quorum is not forthcoming at any meeting, another meeting may be called, subject to the notice requirement set forth above, and the required quorum at such subsequent meeting shall be one-half of the required quorum for the preceding meeting. No such subsequent meeting shall be held more than sixty (60) days following the preceding meeting. In the event that one-tenth (1/10) of the class B membership, if any, are not present in person or by proxy, the Members not present may give their written assent to the action taken thereat.
