### AFFIDAVIT FULFILLMENT OF PARTNERSHIP AGREEMENT

The purpose of this affidavit is to certify that SCIENCE OF LIFE, THE PROSPERITY CHURCH, INC., has more than fully complied with all the terms and conditions of the Agreement entered into February 24th, February 28th, and March 2nd, 1976, by and between SCIENCE OF LIFE, THE PROSPERITY CHURCH, INC., a not-for-profit Florida corporation incorporated May 5th, 1975, and Tad Galin and June Galin.

AS A GESTURE OF GOOD WILL, be it known that whereas the Agreement calls for the Galins to own but fifty percent of the partnership, SCIENCE OF LIFE, THE PROSPERITY CHURCH, INC., hereby assigns, grants and transfers ONE HUNDRED PER CENT of the Corporation to the Galins, and includes all of the Corporation's assets which, specifically include all right, title and interest in the following publications: 1. A POCKETFUL OF MIRACLES. 2. GOD'S IMAGE, YOU ARE A WINNER! 3. THE MIRACLE WAY TO PROSPERITY HERE AND NOW! 4. THE MAGIC KEY TO HEALTH, WEALTH AND HAPPINESS THROUGH MEDITATION! 5. Ordination Certificates. 6. ID Cards. 7. Charter forms. PLUS an inventory of each item.

IN ADDITION, SCIENCE OF LIFE, THE PROSPERITY CHURCH, INC., also hereby assigns, grants and transfers all right, title and interest in a subsidiary enterprise known as AMBASSADORS FOR PEACE, plus an inventory of various pieces of promotional literature and Rubber Stickers.

When in questionable motivation the Galins walked out they took with them the partnership checkbook, valuable records, a private telephone book, and other items of value, and refused to wholeheartedly cooperate in running the business, and vented their hostility in malicious and vicious attacks of slander.

However, AS A GESTURE OF GOOD WILL, and consciously aware that a harmonious working relationship is unlikely, SCIENCE OF LIFE, THE PROSPERITY CHURCH, INC., gives the entire properties outright to Tad Galin and June Galin, so they may as vigorously promote the entire operation on their own as they may desire. Legal transfer papers await the Galins at the office of our Attorney, Ronald H. Brimmel, of the Law Firm, BRIMMEL AND GRAHAM, 1400 East Oakland Park Boulevard, Fort Lauderdale.

This affidavit serves official notice that all obligations of SCIENCE OF LIFE, THE PROSPERITY CHURCH, INC., have been MORE THAN FULLY COMPLIED WITH and the partnership is hereby automatically dissolved.

COMPLAINT

(1) This is an action for damages that exceeds Twenty-five Hundred

(\$2,500.00) Dollars.

(2) The Plaintiffs TAD GALIN and JUNE GALIN, (hereinafter referred to as GALINS) are residents of Broward County, Florida.

(3) The Defendant, RAY CAMERON, (hereinafter referred to as CAMERON) is a resident of Broward County, Florida, and is the president and director of SCIENCE OF LIFE, THE PROSPERITY CHURCH, INC.

(4) The Defendant, SCIENCE OF LIFE, THE PROSPERITY CHURCH, INC., is a Florida corporation.

COUNT I  
(BREACH OF CONTRACT)

(5) All the allegations contained in Paragraphs 1 through 4 are hereby realleged.

(6) On or about March 2, 1976, GALINS and CAMERON entered into a written contract, a copy of which is attached hereto, marked Exhibit A, and incorporated herein. Said contract is recorded in Broward County Official Records Book 6576, at Page 535.

(7) As consideration for the contract, GALINS tendered to CAMERON the sum of Ten Thousand (\$10,000.00) Dollars. CAMERON required the money to be paid as follows: Four Thousand (\$4,000.00) Dollars payable to "Scientific Meditation Institute of America"; Five Thousand (\$5,000.00) Dollars payable to "The Science of Life;

money in the amount of Ten Thousand (\$10,000.00) Dollars from GALINS for which GALINS have not received their share of the income and profit.

(14) The GALINS have demanded an accounting from CAMERON but have been refused.

(15) GALINS cannot know or be advised of the present state of affairs of the partnership and/or corporation unless and until they are granted the opportunity to have an accountant or some representative examine the books of account. The Defendants, and both of them, have possession of and arbitrarily retain all books and accounts.

WHEREFORE, Plaintiffs demand an accounting of the books and records of CAMERON and SCIENCE OF LIFE, THE PROSPERITY CHURCH, INC.

#### COUNT III.

##### CONVERSION

(16) Paragraphs 1 through 4 are hereby realleged.

(17) The Defendants have converted to their own use certain assets and income derived from the sales efforts of Science of Life, The Prosperity Church, Inc., Harmony Mail Order of The Magic Key and Ambassador of Peace International that was then the property of the Plaintiffs. The Plaintiffs cannot ascertain the value of this property at this time.

WHEREFORE, Plaintiffs demand judgment for damages against Defendants including costs and attorneys' fees.

#### COUNT IV.

##### FRAUD

(18) Paragraphs 1 through 17 are hereby realleged.

(19) CAMERON falsely represented to GALINS the following:

- a) That GALINS would be equal partners with CAMERON.
- b) That GALINS would possess equal ownership in the corporation with CAMERON.
- c) That the income and future was unlimited in this long proven successful enterprise.
- d) That Ten Thousand (\$10,000.00) Dollars buys fifty percent interest in this sound and profitable business.
