AMENDMENT TO THE

ARTICLES OF INCORPORATION OF

PARK PLACE OWNERS ASSOCIATION, INC.

Article XII, Sections 12.2 and 12.3, of the Articles of Incorporation are amended to read as follows:

Amendments to these Articles of Incorporation shall be proposed and adopted in the following manner:

- 12.2 A resolution for the adoption of a proposed amendment may be proposed by the Board of Directors of the Association or by the members of the Association. Members may propose such an amendment by instrument in writing directed to the President or Secretary of the Board signed by not less than ten (IO %) percent of the membership. Amendments may be proposed by the Board of Directors by action of a majority of the Board at any regularly constituted meeting thereof. Upon an amendment being proposed as herein provided, the President, or, in the event of his refusal or failure to act, the Board of Directors shall call a meeting of the membership to be held not sooner than fifteen (I5) days nor later than sixty (60) days thereafter for the purpose of considering such amendment. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing provided such approval is delivered to the Secretary at or prior to the meeting. Except as elsewhere provided, such approvals must be by the affirmative vote of fifty one percent (51%) of the votes cast at a meeting at which there is a quorum. either by:
 - (a) Not less than a majority of the entire membership of the Board of Directors and by not less than a majority of the votes of the members of the Association.
 - (b) Not less than sixty six and two thirds (66-23%) percent of the votes of the entire membership of the Association.
- 12.3 Provided, however, that no amendment shall make any changes in the qualifications for membership nor the voting rights of the members, nor any change in Section 3.3 of Article III, without approval in writing by all members and the joinder of all

record owners of mortgages on the Condominium Units, including the Developer. No amendment shall be adopted without the consent and approval of the Developer, so long as it shall own five (5) or more condominium units in the PARK PLACE CONDOMINIUMS. No amendment shall be made that is in conflict with the Condominium Act or the Declaration of Condominium, nor shall any amendment make any changes which would in any way affect any of the rights, privileges, powers and/or options herein provided, in favor of or reserved to the Developer, or any person who is an Officer, Stockholder or Director of the Developer, or any corporation having some or all of its Directors, Officers or Stockholders in common with the Developer, unless the Developer shall join in the execution of such amendment.
