## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF ICHETUCKNEE RIVER ESTATES HOMEOWNERS' ASSOCIATION, INC.

Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida not-for-profit corporation adopts the following amendment to its Articles of Incorporation:

#### **ARTICLE XV**

### Procedure for Sale, Encumbrance or Alienation of Real Property

No interest in real property owned by the Association shall be sold, conveyed, encumbered or otherwise alienated except as follows:

- 1. The Board of Directors shall adopt a resolution (the "Resolution") setting forth the terms and conditions of sale, conveyance, encumbrance or alienation of real property and providing for a vote of members entitled to vote at either an annual or a special meeting of the members.
- 2. Each member entitled to vote shall be given written notice and a copy of the Resolution.
- 3. To be approved, the Resolution must receive at least a majority of the votes that members who are present or represented by proxy are entitled to cast.

We, David Hanna and George Hertel, being the President and Secretary respectively of Ichetucknee River Estates Homeowners' Association, Inc., a Florida not-for-profit corporation, do hereby certify that this Amendment to the Articles of Incorporation of Ichetucknee River Estates Homeowners' Association, Inc. was properly adopted in accordance with Article XI of the Articles of Incorporation and Florida Statute Chapter 617.1002.
