A resolution to dissolve was adopted by the Board of Directors of CENTRAL FLORIDA BUILDERS' EXCHANGE (the "Company") on January 22, 2013. The Company filed Articles of Dissolution with the Florida Department of State. The Articles were filed on MAY 23, 2014. Dissolution was effective upon filing.

This Plan of Distribution of Assets (the "Plan") was adopted in accordance with section 617.1406, Florida Statutes, at a meeting of the Board of Directors by a majority of the Directors then in office.

The Company will provide for claims against it in accordance with sections 617.1407(1)(a) and 617.1408 by filing notice of its dissolution with the Florida Department of State and requesting that persons having claims against the Company present them in accordance with the notice. The Company is not aware of any claims against it, the Company having paid, satisfied and discharged all known claims.

Real and personal property formerly owned by the Company has been liquidated in a commercially reasonable manner. Net proceeds were used to pay

all known claims and for legal and accounting services and then distributed to Trudi Larson, President, in recognition of 40 years of faithful service to the Company, to ACE Mentor Program of Central Florida, Inc., to Valencia College Foundation, and to Great American Insurance Group (for D & O tail coverage).

The sole remaining property of the Company is cash. The Company intends to distribute all of its remaining cash to the Valencia College Foundation.

I hereby certify that the Company has complied with the requirements of section 1406(2), Florida Statutes.
