



Pursuant to the provision of Chapter 617, Florida Statutes, the undersigned corporation adopts the following Amendment to the Articles of Incorporation.

AMENDMENT TO THE ARTICLES OF INCORPORATION OF GULF HARBORS WOODLANDS ASSOCIATION, INC.

1. Articles VII and VIII of the Articles of Incorporation of Gulf Harbors Woodlands Association, Inc. is amended to read as follows:

VII.

1. The By Laws Bylaws of the corporation shall be adopted by the Board of Directors who shall have the power to alter, amend, or rescind the same altered, amended or rescinded as provided within the Bylaws.
