Pursuant to the provision of Section 617,1006 Florida Statutes, the undersigned Florida Nonprofit Corporation adopts the following Articles of Amendments to it's Article of Incorporation.

First: Amendment adopted: Article IV is to be deleted and substituted with updated clause with the following:

The General Overseer shall be determined by the General Supreme Executive Board, The General Supreme Executive Board shall have the power to remove by a majority vote, Walter Camps, Sr., or any other person that would be in the best interest of the organization.

Second: The Amendment date of adoption of the Amendments was April 30th 2002.

Third: The Amendments were adopted by the members and the number of votes cast for the Amendment was sufficient for approval.
